FY27 FINAL BUDGET PRESENTATION & BOARD APPROVAL

Sherry reviewed the draft budget with the board. The proposed budget has an overall increase of 1.72%. The revenues include use of \$239,000 of undesignated fund balance and reflects a slight decrease in state subsidy and a slight increase in the local assessment. The Adult Education budget remains flat with no increase in the local assessment request. Food Services revenues include use of \$14,736 in undesignated fund balance and a decrease in the local share. Seth commented that the local schools in the region were experiencing budget difficulties this year.
